
- a) To appraise the stakeholders about standards on Printing Machinery and its safety aspects




Industry Meet with focus on collective journey from Independence to Atmanirbhar in Quality


DoCA iconic Week under Azadi ka Amrit Mahotsav

A quiz competition based on the topics discussed in the event was conducted among the students present (34 students) and the top three participants were given cash prizes.

About 50 students of 9th and 10th standard participated in the program. The students were informed about the needs of the Legal Metrology Science.




Webinar on 'This week That day'

The Webinar was well attended by about 220 members from Consumer bodies, Industry Associations, SDOs, Technical Committee members, Govt. bodies and other stakeholders.






A webinar on "Requirements of e-commerce websites" was conducted on 09.08.2021. Participants from industries and other areas took part in the webinar.





Webinar on "Reaping Benefits from Indian Soil – Standards on Agriculture"






Webinar on the topic "Testing and Quality Evaluation of LED based Lighting System"



A webinar on "Awareness program on requirements of e-commerce websites for the industries" was organised by RRSL Bhubaneswar on 11.06.2021.




Standards Club Activity in Schools/ Colleges, Raipur
