
In continuation to the corrigendum issued earlier on 11th October, 2023, 18th October, 2023, 26th October, 2023, 03rd November, 2023, 9th November, 2023 and reference to Online e-tenders invited by DoCA, vide RFP notice dated 19.09.2023 for "Engagement of Management Consultant for Strategic Transformation Support for Bureau of Indian Standards and DoCA", it may be noted that the following changes have been made in the RFP:

- (i) Cl 4.8 of RFP document- Time Schedule "Study and submission of the draft report will be in first 10 months. Submission of interim report, concurrent evaluation and concurrent implementation wherever applicable and feasible shall be done in a phased manner. Evaluation, review of the project, deliverables and acceptance of restructuring transformation plan shall be done in next 2 months. Increasing international presence, marketing & brand building, organisation structure & capability building, concurrent evaluation Digitalisation, transformation, implementation, handholding of BIS & DoCA etc. should be completed in last 6 months. The total contract period will be of 18 months".
