#### **EXPRESSION OF INTEREST**

Expression of interest (EOI) is invited from the Insolvency Professionals / Agencies registered with the Insolvency and Bankruptcy Board of India (IBBI), New Delhi for completing the work relating to the Liquidation of the Cooperative store Ltd., (Super Bazar) Delhi. The application of EoI may be submitted to Shri D.K. #### Background note of the cooperative stores on Super Bazar

The Cooperative Stores Limited, Super Bazar, Delhi was established in 1966 under Bombay Cooperative Societies Act. Thereafter, in 1996 it was registered as a Multi-State Cooperative Society (MSCS) under the Multi Sate Co-operative Societies Act, 1984 (later amended in the year 2002). The total Number of employees working in Super Bazar in the year 2001 were 2065. The Super Bazar started incurring losses since 1996 and its accumulated losses were going upward regularly on account of overstaffing, failure of management, inadequacy of working capital, lack of competitive approach on part of the management etc. The Board of Directors of Super Bazar decided to close the operations of the society and recommended for its winding up. The Department of Consumer Affairs being administrative department placed the matter before the Union Cabinet on 15.10.2001. The Union Cabinet in its meeting held on 16.10.2001 decided to close the society and approved a sum of Rs. 44.20 crores (approx.) as minimum compensation payable to the employees and additional expenditure on account of salary at the rate of Rs. 1.50 crore per month from April 2001 onwards till the actual date of retrenchment. A total of Rs. 23.34 crore were paid to the outgoing 1000 employees under VRS (gratuity, leave encashment and compensation @ 15 days for each year of completed service). Further, an amount of Rs.12.00 crore (approx.) was paid on account of salary to all the employees either till the date of their separation under the VRS or till 15.05.2003 i.e. the date of retrenchment announced by the liquidator in accordance with the provisions of section 25 of the Industrial Disputes Act 1947.

- 1. Under section 77 of MSCS Act, 1984 Central Registrar of Cooperative Societies, Department of Agriculture and Cooperation, Government of India issued orders on 05.07.2002 for winding up of Super Bazar. After the winding up of the Super Bazar, a voluntary retirement scheme was offered to all the employees of the society on 17.09.2002 However, out of 2065employees at that point in time only 1000 employees opted for VRS and the remaining employees did not opt VRS. The Worker's Unions of Super Bazar namely (i) Super Bazar Karamchari Dalit Sangh (ii) Super Bazar Karamchari Hitaishi Sangathan and (iii) Delhi Shops and Establishment Union filed a number of Writ Petitions in High Court of Delhi challenging the order of winding up of Super Bazar, which were dismissed by the Hon'ble High Court of Delhi on 19.12.2003. Thereafter, the Super Bazar Karamchari Dalit Sangh filed a review petition in the Delhi High Court and the same was dismissed on 19.03.2004 without giving any relief to the workmen of Super Bazar.
  - 2. One of the Unions namely Super Bazar Karamchari Dalit Sangh filed an appeal before the Hon'ble Supreme Court in January 2005. After a detailed hearing of the case, the Hon'ble Supreme Court constituted a committee on 28.02.2006 comprising three officers i.e. (i).

Economic Adviser, Department of Consumer Affairs (ii) Central Registrar of Cooperative Societies and (iii)Official Liquidator(Shri A K Misra) to explore the possibility of its revival and submit a comprehensive scheme which in their view is feasible. Thereafter, in compliance to the order dated 05.05.2006 passed by Hon'ble Supreme Court the bids were invited. The report of the said committee was placed before the Hon'ble Supreme Court. Subsequently, the Hon'ble court vide its order dated 12.07.2007 directed the Official Liquidator and Central Registrar of Co-operative Societies to invite fresh bids within 4 weeks in view of the consortium of Indian Potash Ltd and M/s Indian Labour Co-operative Society having fallen. In pursuance of directions of the Hon'ble Court bids were invited and a report submitted before the Hon'ble Court. Subsequently, on 07.05.2008 the Hon'ble Supreme Court directed the above mentioned three member committee to reconsider their recommendations in light of the demands of the workers concerning their dues. The Committee submitted its report on 22.08.2008. The Hon'ble Court further directed the bidders to submit their revised bids on 08.09.2008. Thereafter, on 23.09.2008 the Hon'ble Supreme Court upon one of the members (the Economic Advisor) having been transferred, reconstituted the committee which comprised -(i) Secretary to the Government of India in the Department of Consumer Affairs (ii) Central Registrar of Co-operative Societies and (iii) Official Liquidator (Shri A K Misra) with the direction for the reconstituted evaluation committee to vet the revised bids and submit it recommendations. The recommendations made by the evaluation committee in favour of M/s Writers and Publishers Ltd. (WPL) in its report dated 05.11.2008 were accepted by the Hon'ble Supreme Court in entirety vide order dated 26.02.2009.All the three worker unions mentioned in para 2above accepted the report.

- 3. The new management of Super Bazar started operations in July, 2009 and the same were continued upto March, 2016. However, the selected agency and the worker's unions had serious differences which disrupted the revival. The worker's unions of Super Bazar also filed number of contempt petitions and Interlocutory Applications (IA) before the Hon'ble Supreme Court against the new management of Super Bazar. Considering serious differences between the worker's unions and management, M/s WPL Ltd. finally, during the hearing held on 23.02.2016 requested the Hon'ble Court for withdrawal of their offer with the request that the amount invested by them may be returned with interest.
- 5. On 29.03. 2016 after a series of discussions and pleadings, the Hon'ble Supreme Court observed that "despite earnest efforts made by this court ever since the acceptance of the bid of M/s WPL and despite a series of hearings in the matter ever since 2009, it came to be realized that it would not be possible to give effect to the terms of revival". The Hon'ble Court upheld the winding up order and directed the Official

Liquidator to appoint a chartered valuer to assess the value of the property having clear title and bring to sell all these properties within 9

months i.e. before 31.12.2016. The Hon'ble Court also directed to conduct audit of Super Bazar for the year 2009-10 to 2015-16 by C&AG to determine the income and expenditure incurred by M/s WPL Ltd. The Court further directed to release the payment of M/s WPL Ltd., on first priority and thereafter the Official Liquidator shall proceed in accordance with law.

- 6. The worker unions also filed a review petition as well as a curative petition before the Hon'ble Supreme Court. All these petitions were dismissed by the Hon'ble Court without granting any relief to the workmen of Super Bazar.
- The Hon'ble Supreme Court in its order date 29.03.2016 directed that "the C&AG of India to nominate an auditor, to verify, the income and expenditure incurred by M/S WPL and also the profit earned by it from the Super Bazar establishment, during the period under consideration. The determination so made by the auditor will be verified by the office of the C&AG of India, whereupon, the same shall be binding on all the parties including M/S WPL." The C&AG started the audit of Super Bazar on 01.08.2016 and completed the same on 30.06.2017. The Audit Report was submitted by CAG on 01.09.2017 to the Liquidator, Super Bazar. This report was placed before the Hon'ble Supreme Court on 04.09.2017 for direction.
- 8. Meanwhile, in compliance of the order dated 29.03.2016, the Official Liquidator appointed a chartered valuer of Income Tax Department having experience of more than 30 years in valuation of the property. The valuation of the property was undertaken by the chartered valuer before the demonetization and the reserve prices of the properties were fixed on the basis of the report given by the chartered valuer. All factors such as location of the property, circle rate and present market value were taken into consideration while deciding the reserve price of the shops of Super Bazar.
- 9. Accordingly, the Official Liquidator gave a public notice in daily newspapers i.e. Times of India and Navbharat Times for sale of Super Bazar shops and also engaged an agency i.e. C1 India Ltd. (which was the main agency for auction of Bank properties) for E-auction. The details of bidders, sale price and location of property was placed before the Hon'ble Supreme Court on 27.04.2017. The Hon'ble Court granted permission to sell the properties in favour of the bidders and also directed to deposit the sale proceeds in an Escrow account of the nationalized bank for onward payment to M/s WPL Ltd. The entire exercise has been completed under the supervision of Hon'ble Supreme Court.
- 10. The CAG has submitted its report before the Hon'ble Supreme Court on 04.09.2017. The M/s Writers and Publishers filed a contempt petition against the Official Liquidator including challenging the CAG report. The Hon'ble Supreme Court in its hearing held on 19.03.2018 directed as under:-

"This is an application for amending the contempt petition. The same stands allowed. The contemnor is permitted to file the reply to the amended contempt petition within two weeks. Let all these matter be listed on 06.04.2018".

#### Brief of CAG report.

The CAG has submitted its report to Official Liquidator, Super Bazar on 01.09.2017. The brief of the report is given below:

#### PART -IV

<u>General Observations of CAG:</u> Apart from the issues mentioned above, the following important points which may be considered while determining claims of M/s WPL during the process of liquidation of Super Bazar:

- 1. Reference is invited to Point no. 6 of the report of M/s SPMG & Co., Chartered Accountants, wherein it is highlighted that there are some liabilities (Government/statutory dues and Government loan) to the tune of ₹ 248.71 crore which are not part of the books but they might become payable at a later stage.
- 2. As per the minutes of the meeting held on 24.06.1996, the amenities like lifts, showcase etc. were to be provided by the NDMC at Super Bazar building, Connaught Place, New Delhi. While handing over Super Bazar building on 10.05.2016 by M/s WPL to the Official liquidator of Super Bazar, it was categorically mentioned in point no. 4 that the lifts are not available. CAG audit team agrees with the remarks of the of M/s SPMG & Co. (Pg.- 69 point no. 2 of report).
- 3. One of the criteria in evaluation of revival bid for Super Bazar was "As per the bid document of M/s WPL, the liabilities of Super Bazar will be discharged within three months or as per the requirement for discharge of the liability by the administrator. On issuing the fresh equity, the said amount of equity shall be first utilized for paying all the liabilities of suppliers/creditors/other local authorities etc." Despite this assurance, M/s WPL did not fulfil their promise of discharging the liability towards the sundry creditors of Super Bazar and the creditors of ₹ 26.05 crores in 2009-10 remained unpaid. In the end of the year 2015-16, the same stood in the balance sheet at ₹ 26.63 crores.
- 4. Bids were called for revival of Super Bazar on the direction of Hon'ble Supreme Court. An Evaluation Committee constituted by the Hon'ble Supreme Court evaluated received bids for revival of Super Bazar from M/s NCCF India Limited and M/s Pantaloon Retail India Private Limited. The Evaluation Committee decided in favour of M/s WPL considering its revival bid of ₹ 504 crore, which includes ₹ 102 crore towards Share Capital, ₹ 276 crore towards working capital and ₹ 126 crore towards revival & revamping. Against these commitments, M/s WPL brought ₹ 102 crore towards Share Capital and the maximum working capital infused in piece meal manner over a period of 6 years was ₹ 28.79 crore as on 31.12.2015, which was subsequently withdrawn and reduced to ₹ 9.34 crore as on 31.03.2016. This has resulted in shortfall of ₹ 247.21 crore towards working capital, whereas, the amount of ₹ 126 crore towards revival and revamping was never brought in by

M/s WPL, taking the total investment to be made (as per revival bid submitted) short by ₹ 373.21 crore.

If the above amount of ₹ 373.21 crore were had been arranged from the market, there would have been an interest cost of ₹ 223.92 crore at the rate of 9 per cent for a period of 6 years and 8 months (August 2009 to March 2016), considering the minimum shortfall of ₹ 373.21 crore at any given point of time. Hence, the fact that M/s WPL did not completely fulfil its commitment to bring fund to the tune of ₹ 373.21 crore as per its submitted revival bid, is highlighted in view of the fact that the Hon'ble Supreme Court ordered (29.03.2016) that M/s WPL should be refunded the entire investment made by them, along with the interest at the rate of 6 per cent annum (though M/s WPL has claimed refund of investment alongwith interest at the rate of 9 per cent per annum).
