Ministry of Consumer Affairs, Food and Public Distribution (Department of Consumer Affairs)

The following are the important activities of Department of Consumer Affairs during the month of January, 2020.

1. Pulses and Onion Buffer Stock:

- 1.1 Three Video Conferences with States / UTs were held during the month to review the demand of Imported Onion and Pulses from Central Buffer to States / UTs for retailing and related matters. Letters were also sent to States by Hon'ble Minister, CA, F&PD and Secretary (CA) requesting States to confirm their requirements and take appropriate measures to restrain the onion price rise.
- 1.2 Of total arrival of 36,124 MT of imported onion during the month, dispatches was arranged to Delhi, Andhra Pradesh, Kerala, Telangana, U.P., Assam, J&K, Uttarakhand etc. Mother Dairy, NCCF, Kendriya Bhandar and NAFED were advised to retail imported onion to cool down their prices.
- 1.3 As on 31.01.2020, 3791.7 MT of imported Onion was disposed through supply to States / UTs based on their requirement and through auction. In addition, disposal of 6669 MT was under progress.
- 1.4 Two Weekly Review Meetings on management of buffer stock under PSF were held during the month of January.
- 1.5 Three meetings of IMC to review prices of essential commodities were held during the month.
- 1.6 As per the recommendation of the CoS meeting of 7th January, 2020, supplies of imported onions through agencies like Safal, Kendriya Bhandar, state agencies was undertaken to the extent these agencies were willing and able to lift. Approval for meeting the transportation cost from port to state from the PSF was obtained and States / UTs were requested to take onion on the revised conditions. States were also requested through video conferences to honour their commitments. Chairman of the CoM was also apprised of the situation.

2. National Cooperative Consumers' Federation of India (NCCF):

2.1. The Civil Services Board (CSB) in its meeting held on 13.01.2020 has recommended the name of Sh. Manoj Kumar Semwal, IRSEE (1992) for appointment as MD, NCCF. With the approval of Hon'ble Minister CAF&PD, the recommendation of CSB was accepted and communicated to the DOP&T for appointing Sh. Manoj Kumar Semwal as MD, NCCF. The decision of DOP&T is awaited.

2.2 Shri Kamal Chowdhery, the then MD, NCCF filed an OA before Hon'ble CAT on 22 April 2019 for quashing the suspension as well as chargesheet and repatriation to his parent Department. The request of Sh. Chowdhery for revoking suspension and repatriation to the Parent Department has been considered by the committee and submitted its recommendations to the Competent Authority. Consequently, the suspension of Sh. Chowdhery was revoked w.e.f 05.11.2019 and DOP&T has been requested to consider the proposal of repatriation of Sh. Kamal Chowdhery, IDAS prematurely in his parent cadre. The case was dismissed by the Hon'ble CAT on 25.11.2019 with direction to the respondents to finalise the issue pertaining to the premature repatriation of the applicant within two months from the date of receipt of a certified copy of the order. The DOP&T vide order dated 27.12.2019 accorded approval for repatriation of Sh. Chowdhery to his parent cadre i.e CGDA. Consequently, this Department vide order dated 20.01.2020 has relieved Sh.Chowdhery with the direction to report to his parent cadre with immediate effect.

3. Bureau of Indian Standards (BIS):

- 3.1 Quality Control Order for Mandatory Hallmarking of Gold Jewellery and Gold Artefacts Order, 2020 has been notified in the Gazette of India vide S.O. No. 205€ dated 15-01-20 making hallmarking of Gold jewellery and artifacts mandatory in the country w.e.f. 15-1-2021 giving a year's time for its implementation.
- 3.2 The 7th annual meeting of the Indo-German Working Group on Quality Infrastructure, led by the Ministry of Consumer Affairs, Food & Public Distribution, Govt. of India and the German Federal Ministry for Economic Affairs and Energy was hosted at India Habitat Centre, New Delhi during 16th and 17th January 2020. The meeting was concluded with signing of Work Plan 2020 for implementation by both the sides. The work plan was signed by Secretary, Department of Consumer Affairs and Director General, German Federal Ministry of Economic Affairs and Energy.
- 3.3 BIS (India) membership in ISO Technical Management Board (TMB) for the 2020-2022 term has started from 1st January, 2020. The ISO-TMB is responsible for setting up the various technical committees (TC), appointing TC chairs and monitoring the progress of the technical work. It is also responsible for the Directives, which are essentially the rules for the development of International Standards, and it deals with all matters of strategic planning, coordination, performance and monitoring of technical committee activities.
- 3.4 The Laboratory at Eastern Regional Office, BIS has created complete testing facility for Microbiological parameter for PDW as per IS14543:2016 & PNMW as per IS 13428:2005.

Price Monitoring Cell (PMC) of the Department of Consumer Affairs monitors the retail and wholesale prices of 22 essential commodities on daily basis from 114 centers across the country. These prices are reported by State Civil Supplies Departments on daily basis mainly through online portal. These prices are being disseminated through the Department's website immediately. Because of the online price reporting, the time taken for reporting and disseminating is less. As per instructions / guidelines even other routine office work is being shifted on line to reduce delays and for more efficient results.
