Number of pages	Estimated number of pages are 266 Pages each in English and Hindi Versions. (Pages can vary and charges will be calculated on Pro-rata basis on less/extra pages if different from 266 pages)

Text will be in two columns format with side border having pictures and logo on every page. <i>Cover page, back Cover and each chapter of Annual Report including photos will be designed by a professional designer of the Printer</i> for both versions of the reports. Cover will be laminated in Mat surface. Perfect bound side stitching will be required for binding the Annual Report.
