G.S.R. – In exercise of the powers conferred by the proviso to article 309 of the Constitution, and in supersession of the National Test House, Assistant Workshop Superintendent Recruitment Rules, 2017, except as respect things done or omitted to be done before such supersession, the President hereby makes the following rules regulating the method of recruitment and conditions of service for the post of Assistant Workshop Superintendent in the National Test House, under Ministry of Consumer Affairs, Food and Public Distribution, Department of Consumer Affairs namely :-

1. Short title and commencement. – (1) These rules may be called the National Test House, Assistant Workshop Superintendent Recruitment Rules, 2025.

(2). They shall come into force on the date of their publication in the Official Gazette.

2. Application- These rules shall apply to the posts specified in column 1 of schedule annexed to the rules.

3. Number of post, classification, level in pay matrix.– The number of post, it's classification, level in the pay matrix attached thereto shall be as specified in columns (2) to (4) of the Schedule annexed to these rules.

4. Method of recruitment, age-limit, educational qualifications, etc.– The method of recruitment, age-limit, educational qualifications and other matters relating to the said post shall be as specified in columns (5) to (13) of the Schedule.

5. Disqualification– No person,-

(a) who has entered into or contracted a marriage with a person having a spouse living;
or

(b) who, having a spouse living, has entered into or contracted a marriage with any person,

shall be eligible for appointment to the said post:

Provided that the Central Government may, if satisfied, that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing exempt any person from the operation of this rule.

6. Power to relax. – Where the Central Government is of the opinion that it is necessary and expedient to so do, it may, by order and for the reasons to be recorded in writing and in consultation with Union Public Service Commission relax any of the provisions of these rules with respect to any class or category of persons.

7. Saving. – Nothing in these rules shall affect reservation, relaxation of age-limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, other

backward classes, ex-Servicemen, Economically Weaker Section (EWS) and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.

Promotion- Maintenance Supervisor or Welding Supervisor or Electrical Charge man in Level-5 of pay matrix with six years regular service in the grade and have successfully completed the training of not less than two weeks in the trade of Fitter or Turner or Miller or Grinder or Shaper or Driller or Welder or Mechanic and Machinist or Electrician from the Industrial Training Institute//Government recognized institute/organization. Note 1: Where juniors who have completed their qualifying or eligibility service are being considered for promotion, their seniors would also be considered provided they are not short of the requisite qualifying or eligibility service by more than half of such qualifying or eligibility service or two years, whichever is less and have successfully completed the probation period for promotion to the next higher grade along with their juniors who have already completed such qualifying or eligibility service.					
Deputation- Officers from the Central Government / State Government / Union territories Administration / Autonomous bodies / Statutory bodies / Public sector undertakings / Research institutions / Central / State Universities:- (a) (i). holding analogous post on regular basis in the parent cadre or Department; OR (ii). with six years' service in posts in the pay level - 05 in the pay matrix (₹29,200- 92,300/-) AND (iii). Two years' experience in Fitter or Turner or Miller or Grinder or Shaper or Driller or Welder or					

Mechanic and Machinist or Electrician in a Central Government office or public sector undertakings or autonomous or statutory bodies.

Note 1: The period of deputation including the period of deputation in another ex- cadre post held immediately preceding the appointment in the same or some other organization or department of the Central Government shall ordinarily not exceed three years.

Note 2: The maximum age limit for appointment by deputation shall not be exceeding 56 years as on the closing date of the receipt of application.
