In exercise of the powers conferred by the proviso to article 309 of the Constitution, and in supersession of the National Test House, Ministry of Consumer Affairs, Food and Public Distribution, Department of Consumer Affairs, Assistant Director (Official Language) Recruitment Rules, 2023, except as respects things done or omitted to be done before such supersession, the President hereby makes the following rules regulating the method of recruitment to the post of Assistant Director (Official Language) in the National Test House, under Department of Consumer Affairs, Ministry of Consumer Affairs, Food and Public Distribution, Department of Consumer Affairs, namely:-
- 1. Short title and commencement. (1) These rules may be called the National Test House, Assistant Director (Official Language) Recruitment Rules, 2023.
- (2). They shall come into force on the date of their publication in the Official Gazette.
- 2. Number of post, classification, level in pay matrix.— The number of post, it's classification, level in the pay matrix attached thereto shall be as specified in columns (2) to (4) of the Schedule annexed to these rules.
- 3. Method of recruitment, age-limit, educational qualifications, etc.— The method of recruitment, age-limit, educational qualifications and other matters relating to the said post shall be as specified in columns (5) to (13) of the Schedule.
- 4. Disqualification.- No person,-
- (a) who has entered into or contracted a marriage with a person having a spouse living; or
- (b) who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post:

Provided that the Central Government may, if satisfied, that such marriage is permissible under the personal law applicable to such person and other party to the marriage and that there are other grounds for doing so, exempt any person from the operation of this rule.

- **5.** Power to relax. Where the Central Government is of the opinion that it is necessary and expedient to do so, it may, by order and for the reasons to be recorded in writing and in consultation with Union Public Service Commission, relax any of the provisions of these rules with respect to any class or category of persons.
- **6.** Saving. Nothing in these rules shall affect reservation, relaxation of age—limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, Other Backward Classes, ex—Servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.

Note 1: Where juniors who have completed their qualifying or eligibility service are being considered for promotion, their seniors would also be considered provided they are not short of the requisite qualifying or eligible service by more than half of such qualifying or eligibility service or two years, whichever is less and have successfully completed the probation period for promotion to the next higher grade along with their juniors who have already completed such qualifying or eligible service.

Note 2: For the purpose of computing minimum qualifying service for promotion, the service rendered on a regular basis by an officer prior to the 1st January, 2016 or the date which the revised level in the pay matrix based on the Seventh Central Pay Commission recommendations has been extended, shall be deemed to be service rendered in the corresponding level in the pay matrix extended based on the Deputation:

Officers from the Central or State Government: -

- (a) (i) holding analogous post on regular basis in the parent cadre or Department; or

The departmental officers in the feeder category who are in the direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly, deputationist shall not be eligible for

(Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other Organization or Department of the Central Government shall ordinarily not exceed three years. The maximum age limit for appointment by deputation shall not be exceeding Fifty six years as on the closing date of the receipt of applications.)

Note: For the purpose of appointment on deputation basis, the service rendered on a regular basis by an officer prior to the 1st January, 2016 or the date from which the revised level in the pay matrix based on the recommendations of the 7th CPC has been extended, shall be deemed to be service rendered in the corresponding level in the pay matrix extended based on the recommendations of the said Pay Commission except where there has been merger of more than one pre-revised scales of pay into one grade with a common level in the pay matrix and where this benefit will extend only for the post(s) for which that level in the pay matrix is the normal replacement grade without up- gradation.
