2. In the event of any CPIO proceeding on leave or post lying vacant for a period of more than three days, his/her link officer will discharge the duties of CPIO in his/her place during such absence. In case of absence of First Appellate Authority for one week or more, the link officer will act as the Appellate Authority in his/her place during such absence. The CPIOs and FAAs will share their ids and passwords with their link officers. The CPIOs shall submit quarterly returns for each quarter by 15th of the month following quarter under report.

3. In the absence of a CPIO/Appellate Authority, the concerned Section Officers/Section/Desk in-charges/AD dealing with the subject, shall put up the RTI related matters to the respective link Officer directly for disposal of such matter to ensure their disposal within the statutorily prescribed time-limit and also for submission of quarterly returns. All the CPIOs and FAAs will clear the RTI applications/appeals immediately on receipt of this order.
