Department of Consumer Affairs invites applications from retired government officers of level of Joint Secretary for rendering assistance in handling

matter of NCCF dealt in this Department. The terms and conditions for engagement of

consultant is as under:

(i) The engagement of the Consultant will be purely on contract basis.

(ii) The person should be well acquainted with the functioning of Central Govt.

Ministries/Department with through knowledge and efficiency of handling court cases

especially in the field of cooperative sector. Persons retired from the Central

Government having experience of relevant field shall be given preference. Candidates

should not be more than 63 years on the last date of receipt of application in the

Department.

(iii) Initially the contract period would be for a period of 6 months, it may be extended or

curtailed. The total period of engagement of Consultant shall not exceed 3 Years or 65

years of age whichever is earlier.

(iv)The person must be proficient in examining the cases, noting and drafting.

(v) The consultant will be paid a consolidated fee which will comprise last pay drawn

plus existing DA as on dated minus pension plus existing Dearness Relief. The payment

would be made on monthly basis.

(vi) Income Tax or any other tax, whichever are applicable will be deducted as per the

prevailing rules at source before effecting the payment for which the Department will

issue TDS certificate.

(vii) The consultant shall be eligible for 8 days leave in a calendar year. This leave will

not be carried forward.

(viii) The candidate will be required to sign a non- disclosure undertaking.

(ix) The Department may terminate the consultant in case he is unable to achieve the

assigned works within the time-frame, the work assigned to him is not satisfactory to the

Department and found lacking in honesty and integrity. Termination shall be effected by

written notice served on the consultant and shall take effect in 15 days of delivery of

such notice.

(x) Department shall also reserve the right to terminate the service of Consultant at any

time without giving any notice and also without assigning any reason.
