G.S.R. — In exercise of the powers conferred by the proviso to article 309 of the Constitution, and in supersession of the National Test House, Ministry of Consumer Affairs, Food and Public Distribution, Department of Consumer Affairs, Administrative Officer Recruitment Rules, 2024, except as respects things done or omitted to be done before such supersession, the President hereby makes the following rules regulating the method of recruitment to the post of Administrative Officer in the National Test House, under Department of Consumer Affairs, Ministry of Consumer Affairs, Food and Public Distribution, Department of Consumer Affairs, namely:-

### 1. Short title and commencement. -(1)

These rules may be called the National Test House, Administrative Officer Recruitment Rules, 2024.

- (2). They shall come into force on the date of their publication in the Official Gazette.
- **2. Application-** These rules shall apply to the posts specified in column 1 of schedule annexed to the rules.
- 3. Number of post, classification, level in pay matrix.— The number of post, it's classification, level in the pay matrix attached thereto shall be as specified in columns (2) to (4) of the Schedule annexed to these rules.
- 4. Method of recruitment, age-limit, educational qualifications, etc.— The method of recruitment, age-limit, educational qualifications and other matters relating to the said post shall be as specified in columns (5) to (13) of the Schedule.
- 5. Disqualification. No person,-
- (a) who has entered into or contracted a marriage with a person having a spouse living; or
- (b) who, having a spouse living, has entered into or contracted a marriage with any person,

shall be eligible for appointment to the said post:

- 6. Power to relax. Where the Central Government is of the opinion that it is necessary and expedient to do so, it may, by order and for the reasons to be recorded in writing in consultation with Union Public Service Commission relax any of the provisions of these rules with respect to any class or category of persons.
- **7. Saving.** Nothing in these rules shall affect reservation, relaxation of age-limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, other backward classes, ex-Servicemen and other special

categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.

- (a) (i) holding analogous post on regular basis in the parent cadre or Department; or
- (ii) with five years' service in posts in the in pay level 10 in the pay matrix (R s.56100

177500/-) and

- (b) possessing the qualifications and experience prescribed as under:-
  - (i) degree of a recognized University or Institute: and
  - (ii) five years' experience in accounts/ administration/establishment work i
  - n a Central Government office or public sector undertakings or autono mous or statutory body.
- **Note 1:** The Departmental Administrative Officer (Grade-I) in the pay level 10 in the pay matrix (Rs. 56100-177500/-) with five years' regular service in the grade will als o be considered along with outsiders and in case he is selected for appointment to the post, the same shall be deemed to have been filled by promotion.
- **Note 2:** The period of deputation including the period of deputation in another ex- c adre post held immediately preceding the appointment in the same or some other or ganization or department of the Central Government shall ordinarily not exceed four years.
- **Note 3:** The maximum age limit for appointment by deputation shall not be exceeding 56 years as on the closing date of the receipt of application.
- **Note 4:** For the purpose of appointment on deputation basis, the service rendered on a regular basis by an officer prior to the 1<sup>st</sup> January, 2016 or the date from which the revised level in the pay matrix based on the recommendations of the Seventh Central Pay Commission has been extended, shall be deemed to be service rendered in the corresponding level in the pay matrix extended based on the recommendation of the said Pay Commission except where there has been merger of more than one pre-revised scales of pay into one grade with a common level in the pay matrix and where this benefit will extend only for the post (S) for which that level in the pay matrix is the normal replacement grade without any up-gradation.
